### 1.1 INTRODUCTION

PANCHPIR WOMEN'S DEGREE COLLEGE, formerly known as PANCHPIR +3WOMEN'S COLLEGE is situated in a tribal dominated area, amidst beautiful landscape at the bottom of Similipal, in the district of Mayurbhanj in Odisha. The prime purpose of this college is to impart higher education to the girl students coming from a poor , tribal and agricultural background . It's the only degree women's college in the subdivision. It started in 1996 by the initiatives of a few generous and education - inclined social workers and administrative officers of the locality. The institution began with only 58 number of students and moved through a shaky and tedious path. Bringing the tribal women from their underdeveloped spheres and showing them a brighter prospect has been a mission. Accepting all the adverse situations as a challenge, the institution blossomed with all possible progressive steps like acquiring Pemanent Recognition and Affiliation from the session 1996-97. From 2009 it got its color and fragrance by achieving Honors permission in two subjects and attempting successfully to open Honours in all the subjects, launching Computer Education and getting 2(F) and 12 (B) from UGC and being able to get the cadre of SAMS Resource centre.

Still there are a lot of challenges for such a small institution to comeover, but with an acute scarcity of manpower and financial potency.
